The **LAINGSBURG MUNICIPALITY**, invites tenders for Tender No: **T02 – 2020/2021: RAISINGS OF LOANS**.

Notice is hereby given in terms of Section 46 of the Municipal Finance Management Act (Act 56 of 2003) and Section 21A of the Municipal Systems Act (Act no 32 of 2000) of the municipality's intention to raise a loan to the value of R 720 000.00 to finance Capital Expenditure that has been approved by Council. The following loan are procured in line with the municipality's Supply Chain Management Policy.

Telegraphic, telephonic, facsimile, e-mailed and late bids will not be accepted. Council reserves the right to accept a tender in full, partially or not at all and is not obliged to accept the lowest tender received.

The **bid must be valid for a period of 120 days** after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and Preferential Procurement Regulations, 2017.


