SUPPLY AND DELIVERY OF ELECTRICITY METERS FOR A PERIOD OF 3 YEARS

Laingsburg Municipality hereby formally invites tenders for the supply and delivery of electricity meters for a period of 3 years.

A prerequisite exists of 80% for functionality, in order to be evaluated on price preference points.

Local content requirements are applicable to this bid as follows:

1	Prepaid Electricity Meters	70%

Completion and submitting of MBD 6.2 and relevant annexures are compulsory. The exchange rate to be used for the calculation of local production and content must be the exchange rate published by the South African Reserve Bank (SARB) at 12:00, the same date as the advertisement date of the tender. Only the South African Bureau of Standards (SABS) approved technical specification number SATS 1286:2011 must be used to calculate local content

Only tenderers who satisfy the criteria stated in the Tender Data are eligible to submit tenders. Tenders may only be submitted on the prescribed tender documents that are obtainable from **Monday, 27 January 2020, 09H00** at **Laingsburg Municipality, 02 Van Riebeeck Street, Laingsburg 6900** during office hours (08H00 – 16H00).

A non-refundable fee of **R500-00 (Five Hundred Rand)**, is payable for the right to tender. The fee must be deposited into the account of the Laingsburg Municipality at **Standard Bank**, Branch Code: **51108**, Account Number **203 247 663**. The reference number for confirmation of payment is **06/2019/2020 - Company Name**.

Completed tenders in a sealed envelope endorsed with: **“Tender 06/2019/2020 – Supply and Delivery of Electricity Meters and for a period of 3 years”** must be placed in the tender box in the foyer between (07H45 – 16H00) at the Municipal Buildings, 02 Van Riebeeck Street, Laingsburg to reach the Municipal Manager not later than **12:00 pm** on **24 February 2020**, after which tenders will be opened in public.

Telegraphic, telephonic, facsimile, e-mailed and late bids will not be accepted. The lowest, or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The **bid must be valid for a period of 180 days** after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and Preferential Procurement Regulations, 2017.
