Laingsburg Municipality hereby invites tenders for the provision of electrical services on an as-needed basis.

This tender is subject to eligibility criteria and bidders must provide proof where required, as specified in the tender document.

**Non-compliance with the eligibility criteria will render the bidder non-responsive.**

Completed tenders in a sealed envelope, endorsed with “**SCM-T-2025-26-004 - Provision of electrical services on an as-needed basis,**” must be placed in the tender box in the foyer between 08:00 – 15:00 at the Municipal Buildings, 02 Van Riebeeck Street, Laingsburg to reach the Municipal Manager no later than **12:00 p.m. on 29 August 2025**, after which tenders will be opened in public.

Tenders may only be submitted on the prescribed tender documents that are obtainable from **Tuesday, 12 August 2025** at the **Supply Chain Management Unit, 02 Van Riebeeck Street, Laingsburg, 6900** during office hours (08h00 - 16h00).

A non-refundable participation fee of **R 700.00 (Seven Hundred Rand)** will be applicable. The participation fee must be deposited into the account of the Laingsburg Municipality at **Standard Bank**, Branch Code **51108**, Account Number **203 247 663**. The reference number for confirmation of payment is **SCM-T-2025-26-004 - Company Name**.
