Laingsburg Municipality hereby invites tenders for the provision of a comprehensive municipal fleet solution to Laingsburg Municipality through a full maintenance lease and/or lease-to-own arrangement.

The successful tenderer must be registered and tax-compliant on the Centralised Supplier Database (CSD). Tenderers can register on www.csd.gov.za.

Only tenders scoring a minimum of **70** out of **100** for functionality will be considered further for evaluation.

Tenders may only be submitted on the prescribed tender documents that are obtainable from **Monday, 21 September 2026** at the **Supply Chain Management Unit, 02 Van Riebeeck Street, Laingsburg, 6900** during office hours (**08h00 - 16h00**).

A non-refundable participation fee of **R 700.00 (Seven Hundred Rand)** will be applicable. The participation fee must be deposited into the account of the Laingsburg Municipality at **Standard Bank**, Branch Code **51108**, Account Number **203 247 663**. Completed tenders in a sealed envelope, endorsed with **“SCM-T-2026-27-009 - Provision of comprehensive municipal fleet solution to Laingsburg Municipality”** must be placed in the tender box in the foyer between 08:00 - 15:00 at the Municipal Buildings, 02 Van Riebeeck Street, Laingsburg to reach the Municipal Manager no later than **12:00 p.m. on Thursday, 22 October 2026**, after which tenders will be opened in public.

Telegraphic, telephonic, facsimile, emailed, and late bids will not be accepted.

The **bid must be valid for a period of 120 days** after the closing date.

The bid will be subject to the Council's Supply Chain Management Policy, the Municipal Preferential Procurement Policy, and the Preferential Procurement Regulations, 2022.

The preferential points system applied (80/20) in terms of the Preferential Procurement Policy is as follows:
