Tenderers must be represented at the site visit/clarification meeting by a person who is suitably qualified and experienced to comprehend the implications of the work involved. The representative must be an official or employee of the Tenderer. No representative at the meeting may represent more than one Tenderer.

A non-refundable participation fee of **R 500-00** (Five Hundred Rand), is applicable.
